

TERMS OF USE

1. Introduction and Overview

These Terms of Use (“Terms”) govern your use of any online service location that posts a link to these Terms and all features, content, and other services that Advantia Health (“Practice,” “we,” “our,” or “us”) owns, controls and makes available through such online service location (collectively, the “Service”).

Our Service is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein. By using our Service, you agree to these Terms and consent to our collection, use and disclosure practices, and other activities as described in our [Privacy Statement](#). **In some instances, both these Terms and separate terms will apply to your use of the Service, which are incorporated herein (“Additional Terms”).** To the extent there is a conflict between these Terms and any Additional Terms, the Additional Terms will control unless they expressly state otherwise. If you do not agree and consent, discontinue use of the Service.

2. Modification of These Terms

We reserve the right, at any time in our sole discretion, to change the terms, conditions, and notices under which our Service is offered, without prior notice. The arbitrator’s award shall be final and binding and may be entered as a judgment in any court of competent jurisdiction.

B. Limited Time to File Claims.

You agree that regardless of any statute or law to the contrary, any claim or cause of action arising out of, related to or connected with the use of the Service must be filed within one (1) year after such claim or cause of action arose or be forever banned.

C. Class Action Waiver.
